## Registration Fee

### Registration fees for the 2010 season are:

<b>1 child</b>	<b>\$150</b>
<b>2 children</b>	<b>\$235</b> (\$150 + \$85)
<b>3 children</b>	<b>\$290</b> (\$150 + \$85 + \$55)
<b>4 children or more</b>	<b>\$325</b> (\$150 + \$85 + \$55 + \$35)
<b>Training-Only Athletes</b> (no meet entry)*	<b>\$75</b> (season is Mar 4th - Jun 21st)

### Registration fee includes:

- Administrative expenses
- Track uniform rental
- AAU registration card
- Club t-shirt

All fees must be paid by 3/25/10 or within 10 days of joining the team. If fees are not paid in full by the given date, your child will not be allowed to participate in any activities (practices, fundraisers, or meets).

### Fundraising / Volunteer Hours

To help offset the additional costs during the season, fundraising activities will be held throughout the season. Athletes will be required to participate **in at least 4 hours** of fundraising activities. If parents wish to do so, a buyout option of **\$40 per child** is available in lieu of the fundraising and volunteer hours.

## 727 Track Club News

### Important Information about the AAU State Meet

Parents,

Congratulations! As a result of their performance at one of the AAU qualifying meets, your child has qualified to participate in the AAU State Track meet in one or more events. The dates of this meet are Thursday, June 21<sup>st</sup> through Sunday, June 24<sup>th</sup>.

The team has opted to rent a large house near the track facility rather than use multiple hotel rooms. The house is located just 3 miles from the track and should provide us with a more comfortable stay while saving us money. We will also use the kitchen to prepare meals instead of eating out for each meal.

In preparation for the meet, we will need to get your approval and signature that your child intends to travel to and compete at the AAU state meet. In the past, the club has lost a significant amount of money registering athletes that then didn't show up. This year, we want to make sure we know who will be attending to avoid this problem.

If your child will be traveling with the team, staying with the team, and eating with the team, it will cost \$75. This covers the athlete's registration, travel to and from Orlando, travel to and from the event, and meals. We have tried to make this as affordable as possible. ***This check must be received no later than Thursday, June 14<sup>th</sup>***. If you are making our own travel and lodging plans, only the \$15 meet registration fee is due.
